## MODERN SLAVERY STATEMENT

This statement has been approved by Terry Barton, CEO of Kingdom Services Group, for the financial year ending 31 March 2026.

This statement was approved by the Kingdom Group Board on 01/05/2026 and is published in accordance with the Modern Slavery Act (2015).

It sets out the steps that we have taken to prevent modern slavery and human trafficking in our business and supply chains during the financial year.

Kingdom Services Group welcomes the Modern Slavery Act and the requirements it places upon businesses in the UK to tackle and permanently eradicate all forms of slavery and human trafficking. We have adopted a zero-tolerance approach to modern slavery and are fully committed to preventing all forms of slavery and human trafficking from infesting our supply chain.

## Supply Chain

Our suppliers and sub-contractors conform to our approach to modern slavery. They are asked to confirm their own approach to modern slavery and provide evidence of their compliance with UK legal requirements around pay and

conditions. We periodically audit suppliers and sub-contractors to verify their approach to modern slavery and will remove any suppliers and sub-contractors who have not taken reasonable steps to comply with our requirements.

## **Due Diligence Processes**

Kingdom Services Group undertakes due diligence when considering new suppliers. We also review our existing suppliers on an annual basis. This includes filling out our supplier registration form and providing copies of their policies and procedures pertaining to Modern Slavery.

Any third-party security agencies on our approved subcontractor list must also maintain ACS status and provide proof of their certificates.

Any third-party agencies that provide workers for production related roles must be registered with the GLAA and provide proof of their Gangmasters License.

Our Ethical Trading – Supply Chain Sourcing Policy forms part of our contract with all our suppliers and they are required to confirm that no part of their business operations contradicts this policy. We may terminate a contract at any time should any instances of modern slavery be discovered.

## **Identification and Mitigation**

We will continue to embed our principles through:

- ensuring our colleagues involved in procurement activity are
  - aware of and follow modern slavery procurement guidance on GOV.UK
  - receive training on modern slavery and ethical employment practices
- ensuring that consideration of the modern slavery risks and prevention are added to our policy review process as an employer and procurer of good and services
- providing colleagues with guidance on the appropriate action to take if they suspect a case of slavery or human trafficking
- continuing to take action to embed a zero-tolerance policy towards modern slavery

## **Performance Indicators**

During 2025–26, 1 instance of suspected modern slavery was reported within Kingdom's operations or supply chain and was escalated to the appropriate authorities, demonstrating the effectiveness of our reporting, escalation, and compliance mechanisms.
